MM T-1 is ORLANDO GARCIA VASQUEZ and his title is
Minister Counselor, Foreign Office, Venezuela. MM T-2 is
MM 1337-S. *(X)(u)*

Case was opened on information that subject was
closely associated with ORLANDO BOSCH, leader of Accion Cubana
(AC) and that he was also friendly with ROLANDO MENDOZA and
WALDO CASTROVERDE, also members of AC in Miami. Subject was
completely identified and interviewed in reference to bombing
matters. He admitted knowing above-mentioned individuals
and denied being a member of AC or any other anti-CASTRO
organization. He claims he is devoting his full time in
managing the Standard gasoline station.

In view of the above, Miami is placing this case
in a closed status.

ORLANDO BOSCH is a fugitive believed to be residing outside of the country and in the past, headed Poder Cubano (PC), which was responsible in the past for several bombings in the Miami area.

[On November 20, 1974, MM T-1 advised that the name, address and telephone number of SYLA CUERVO were in the possession of ORLANDO BOSCH when he was arrested on November 18, 1974 in Caracas, Venezuela. FLA.

On November 20, 1974, MM T-2 advised ROLANDO MENDOZA and WALDO CASTROVERDE were members of Accion Cubana (AC) in Miami. FLA.

On December 5, 1974, Investigator RAUL DIAZ, Organized Crime Bureau, Dade County Public Safety Department (DCPSD), Dade County, Florida, advised that ROLANDO MENDOZA and WALDO CASTROVERDE are closely associated with SYLA CUERVO. CUERVO has a gasoline service station located on West Flagler and 27th Avenue.

On July 31, 1975, MARVIS DUNCONSON, Immigration and Naturalization Service (INS), made file number A12414089, under the name of SYLA ROQUE CUERVO-CASTILLO available. This file revealed Certificate of Naturalization number 9757473

indicating that CUERVO became a U.S. citizen on April 4, 1973 in U.S. District Court in Miami under the name of SYLA ROQUE CUERVO. Petition for Naturalization dated December 13, 1972 indicated his current address to be Apartment 103, at 820 NW 87th Avenue; occupation, service station dealer, Standard Station located at 5688 West Flagler; witnesses to the petition, ~~JOSE RAMOS, 5221 SW 7th Street, Miami, Florida and CANDIDO E. MOLINET, 3661 SW 7th Street, Miami, Florida.~~

The synopsis shown in the INS investigative report dated May 12, 1965 was as follows:

Interviews with persons having knowledge of subject's background and activities in Cuba conducted. He was well known to be anti-communist, and since December of 1959, actively anti-CASTRO. Investigation conducted by INS failed to adduce any evidence of a subversive or derogatory nature relating to the subject.

On August 4, 1975, visual observations of the apartment directory at Fontainebleau Park, the Pinewoods Condominiums, 820 NW 87th Avenue, revealed SYLA CUERVO resides in that building in Apartment 103.
