the Jefferson Parish Sheriff's Office continues its investigation into the ownership of this vehicle, it being noted that the vehicle was purchased in March, 1968, from CHARLES EVANS, using the name LEONARD CUNNING. The bill of sale was dated by MARCELLO's attorney, PHILLIP SMITH, and signed by JOSEPH C. MARCELLO on 10/11/68, ten days after LEONARD CUNNING was killed. This vehicle is presently impounded by the Jefferson Parish Sheriff's Office.

G. WRAY GILL further advised ROTH that CARLOS MARCELLO wants this matter settled immediately as he has lost a large amount of weight and spent many sleepless nights worrying about his son's involvement in this matter.

During the past week, New Orleans District Judge exonerated ~~AARON KOHN~~, Metropolitan Crime Commission, from his "intimidation" of City Councilman ~~EDDIE SAPIR~~ as charged by the New Orleans District Attorney's office. This charge was leveled against KOHN following his public disclosure that SAPIR was a close confidant and associate of New Orleans rackets boss CARLOS MARCELLO. The New Orleans District Attorney's office intends to appeal this ruling.

G. ~~WRAN~~ GILL, attorney for CARLOS MARCELLO, approached Captain ~~FRED ROTH~~, Jefferson Parish Intelligence Unit, and inferred he could help ROTH financially if he could alleviate some of the heat developing out of current Jefferson Parish investigation into car purchased from LEONARD CUNNING, who was shot and killed in Kansas City on 10/1/68. When this car was purchased, MARCELLO's son JOSEPH C. MARCELLO signed as purchaser and MARCELLO fears that his son will be subjected to unfavorable publicity if
