be classified "Confidential - No Foreign Dissemination" and
should be marked "SCOPE" since it was furnished by a sensitive
source in the Israeli field. "SCOPE" material receives restricted
dissemination. This information not previously disseminated.
Interest in same is a result of recently established relation-
ship between Rabbi JULIUS and GREENSPUN.

A confidential source, who has furnished reliable information in the past, advised on 10/14/70 that HANK GREENSPUN (ph) who was from Las Vegas had been in contact with General ELIAHU ZEIRA, Defense and Armed Forces Attache, Embassy of Israel, Washington, D.C. (WDC) (S) CONFIDENTIAL

The "Diplomatic List" published by the U.S. Department of State in November, 1970, confirms the above-described position of General ZEIRA. (S)

GREENSPUN advised General ZEIRA that he had been in contact with one AL SNAPPER who had recently been in Israel discussing wood replacements, such as plastic. SNAPPER was known as a 20th Century Edison because many of his designs had been used in the American Spy Satellite System. (S)

(SNAPPER) had proposed the development of a color coded missile warning system for use in the United States manufactured Phantom jets as a replacement for the existing "dot-dash" warning system. The proposed system would signal the pilot in blue regarding a missile which had just taken off, in white for a missile that was on target and in red for the danger zone. (S)

GREENSPUN and ZEIRA agreed that the "dot-dash" warning system was confusing to pilots when many missiles were fired simultaneously. (S)

GREENSPUN claimed that the new system would not be confusing in that the pilot could immediately take evasive action when the red signal showed. He noted that it was estimated to take \$100,000 to perfect the system but that he would have no problem raising the money, if in ZEIRA's judgement the system was practical. (S)

ZEIRA noted that such a decision must be made in Israel. GREENSPUN agreed to provide a short proposal in writing while ZEIRA made appropriate checks regarding SNAPPER. (S)

The system was to be provided to the Government of Israel, if they desired it, at no cost to them. (S)

The above is provided Los Angeles and Las Vegas for background.
