On 1/25/60 HAROLD E. LEVITT, Dempsey Tegeler and Company, 3287 Wilshire Blvd., Los Angeles, Calif., advised SA's LOGAN J. LANE and FRANK H. TOWNSEND that he had information that SAMUEL GREENSPUN, allegedly a Las Vegas, Nevada, newspaper publisher, was a partner in Kratter Corp. of New York City.

On 6/3/60 CSLA 3923-C, who was the original source of the information that SAMUEL GREENSPUN was connected with Kratter Corp., advised SA LOGAN J. LANE that the GREENSPUN who was connected with Kratter Corp., was the resident of Brooklyn, New York and he was not identical with GREENSPUN, the Las Vegas newspaper publisher.

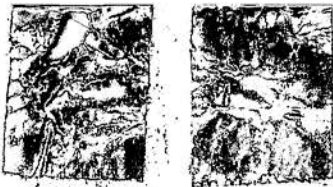
