BOMB THREATS

On the nights of 12/28 and 29/58, Miami Office received telephone threats from an unidentified male individual stating, "We are going to bomb the Miami FBI Office." The caller identified himself as a member of the Confederate Underground. Through contacts with the Telephone Company the office was successful in tracing one of these telephone calls to a public telephone booth located outside of the Cooper Auto Service, Inc., 951 N.E. 2nd Ave., Miami. Investigation in that area so far unsuccessful in identifying subject. Investigation continuing.

West Palm Beach PD furnished West Palm Beach RA with a copy of a City ordinance passed by the City of West Palm Beach on 12/8/58, providing penalties for any person making bomb threats to public buildings or public gatherings. This ordinance was passed as result of recent bombing conferences sponsored in the Miami Division.

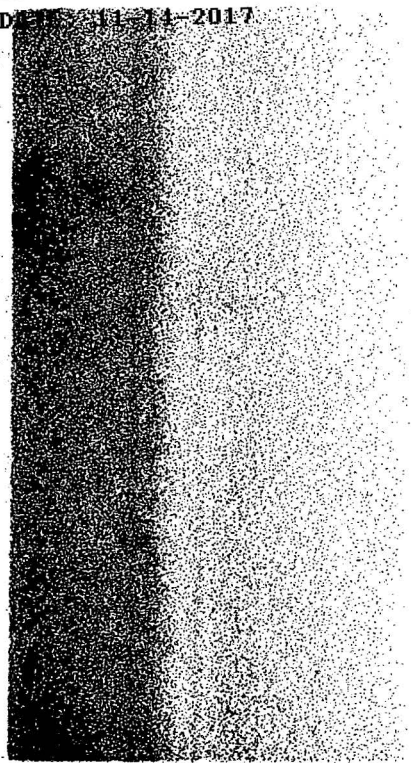

BOXING

FLA ~~PCI LOUIS SACCAROMA~~, who has been associated with boxing as a manager for a number of years, advised that it is his belief that the boxing profession throughout the country is dominated by ~~FRANKIE CARBO~~, Top Hoodlum of the Miami Office. He says that the operations are actively directed by ~~TRUMAN GIBSON~~ and ~~JIM MORRIS~~, who are controlled by CARBO. He states that ex-Heavyweight Champion ~~JOE LOUIS~~ is now working for this group in a public relations capacity, but that his actual assignment is to keep the Negro fighters in line. According to SACCAROMA, the only Negro fighters whom this group has been unable to control are ~~FLOYD PATTERSON~~ and his Manager, ~~GUS AMATA~~, and ~~SUGAR RAY ROBINSON~~ and his Manager, ~~GEORGE CAINSFORD~~. According to the informant, the following Managers and fighters are under the control of this group:

Manager ~~GLINKY PALERMO~~ who manages ~~RAY LUSTER~~; ~~AL WEILL~~, Manager of ~~KEN RENDI~~; ~~DOC KEARNS~~, who has an interest in ~~ARCHIE MOORE~~ and ~~KENNY LANE~~; ~~BILL DALEY~~, who manages ~~VINCE MARTINEZ~~; Manager ~~WILLIE GILZENBERG~~; Manager ~~HYMIE WALDMAN~~; ~~HY GLICKMAN~~, who manages ~~VIRGIL KINS~~ and ~~BOBBIE BOYD~~; Manager ~~WILLIE KETCHUM~~; Manager ~~DAVIE MOORE~~; and ~~CHARLIE JOHNSON~~ who is a partner of ~~DOC KEARNS~~.
