LEGITIMATE AND ILLEGITIMATE BUSINESS ACTIVITIES:

The Legat at Havana, Cuba, advised on December 20, 1956, that the Tropicana Night Club in Havana, Cuba, also continues to be one of the leading gambling establishments in Havana. On December 1, 1956, BISCHOFF took over the operation of this gambling casino. BISCHOFF had been associated with and acted as manager of the Sans Souci Night Club, Havana, Cuba, during the 1955-1956 Winter Season. He now is the only American of any importance connected with the Tropicana Night Club, Havana, Cuba.
