## ADMINISTRATIVE

Five copies of this report are being furnished to the Bureau instead of the usual four copies so that one copy may be forwarded to the Legal Attache, Mexico City, for information, inasmuch as the subject has indicated that he plans to travel to Mexico City in the near future and it is conceivable that investigation by the Legat, Mexico City, may be requested in the future. Careful consideration has been given to each source concealed and a T Symbol was utilized only in those instances where it was necessary to protect the identity of the source.

For the information of the Bureau, MARY LAND, complainant in this matter, advised that she is the sister of three former Louisiana Supreme Court Justices, that she had been living in Monterey, Mexico, and has had contact in the past with one FRED MEYERS (Assistant Legal Attache). She stated that she has lived in Miami and most recently in Jacksonville, Florida, adding that she came to Louisiana in response to a request of CHARLES PORPORA, Louisiana Tax Commissioner. She stated that she was in New Orleans to do some work in connection with the school racial situation in New Orleans and during interview indicated that she was acquainted with Governor JIMMIE DAVIS of Louisiana and was working on behalf of CHARLES PORPORA and/or JIMMIE DAVIS but did not indicate whether this was a gratis arrangement or whether she was being paid by the State
