ReBulet of May 15, 1953.

[Bureau Source 6] advised that on April 23, 1953, the [S] followers of Carlos Prio Socarras (deposed Cuban president) in Mexico City advised the group in Havana that Menela (not otherwise identified) had arrived. It was further stated Ignacio would arrive in Havana on Thursday of that week, by Mexican plane, and they should wait for him and notify Ramona and Maristany.

The same Source stated on May 10, 1953, the group in Mexico City advised Megano and Omega (not otherwise identified) in Havana to deliver to Diego (not otherwise identified) the following instructions from Persilla:

Return to Cayo Lobo directly, giving the date of arrival. Use the radio to give the position of the boat since Cuba and Mexico are intercepting you. Instruct Jack that he must transmit blind from 9 PM to 1 every night. Confirm the departure and arrival at Lobo by way of Havana for greater security.

On May 12, 1953, the Source stated the group in Mexico City advised the group in Havana to inform Tony and the other persons who were to see Persilla in Havana on May 12, 1953, to wait for further notice of his return because of the necessity of his solving unavoidable complications. It was further indicated it would be impossible for Persilla to return to Miami before May 20. The Source stated the group in Mexico City requested the amount and kind of goods produced, and the price, as Prio Socarras did not know about the proposal. It was also stated the matter could then

The Source also advised that on May 12, 1953, the group in Havana advised the group in Mexico City that information had been received from Jack on the previous day, that a friend of Lomberto's should be obtained in Veracruz to guard the goods and that Yeyo (possibly Aureliance Sanchez Arango) is acquainted with the address. It was further indicated that Megano and Omega had indicated they would wait in Ramirez until the following Saturday. ~~(S)~~ (U)
