WINFREY was interviewed on 8/26/64, in connection with an ITSMV investigation involving his close associate, WILLIAM SCHUBERT BEAVER. WINFREY appeared very cooperative and congenial and furnished pertinent information about BEAVER in the ITSMV matter. During the interview gambling matters were mentioned to WINFREY and he furnished pertinent information concerning JOHN ELI STONE, a known Dallas gambler and bookmaker.

On 9/2/64, WINFREY telephonically contacted the agents who had interviewed him and voluntarily furnished some additional information he had obtained about BEAVER. Because of his cooperative attitude, further contacts with WINFREY are being contemplated, with view toward developing him as an informant.
