On 4/1/61 [redacted] Ave., New Kensington, Pa., telephonically requested SA THOMAS G. FORSYTH, III to meet with him at Kings Motel, Monroeville, Pa., and at the time of the meeting BOMBIK advised as follows:

He and others in New Kensington, Pa., have formed the Committee for Good Government. Their purpose, as a factionalist group in the Democratic Party, is to defeat incumbent New Kensington city officials in the election primaries. They feel that most of the present office holders are, in varying degrees, corrupt "rubber stamps" for the MANNARINOS. If they are successful, they will start by trying to suppress racket activities with a view towards ultimate elimination of such activities. He is on the Publicity Committee of the group and it is their task to locate, develop and utilize information concerning the opposition slate members. He fully understands that the FBI cannot furnish any information to his group or assist it in any way but he will be alert for the development of any information concerning activities of the MANNARINOS and their associates which might be of interest to the FBI or other Federal agencies.

[redacted] desires that his identity be protected and does not want to speak with representatives of other agencies.

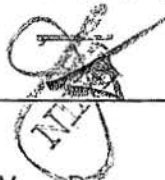
