On 4/12/61, PG 612-C advised SA THOMAS G. FORSYTH, III, as follows:

The rumor still persists in New Kensington, Pa., gambling circles that the MANNARINO horse-room, known as Andy's Pool Room, basement 1195 Fifth Ave., New Kensington, phone Edison 5-3311, receives its race results from somewhere in or near New Orleans, La. As yet, it is not known whether the results are received by telephone, telegram or teletype, but efforts will continue to ascertain how results are received.

On the same date, a PCI of the Pittsburgh Office was instructed to visit the aforementioned horse-room and gather as much pertinent information as is available.

New Orleans will advise if there is any known wire service in its division to which the MANNARINOS may subscribe.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANCEROUS.
