ANDY MANGINI, who helps manage the Mannarino owned gambling casino at 1195 Fifth Ave., New Kensington, Pa., and who has acted as a "strong-arm collector and enforcer," is building a new house in the Rossmont Plan. This area is located near the New Greenwald Grade School on Leechburg Road, New Kensington, Pa., and all of these houses cost \$35,000 and up. At the same time, MANGINI will have a backyard swimming pool installed by VICTOR STANZIANO, local pool contractor.

Also, KELLY MANNARINO has made a deal with STANZIANO to install a 20 foot by 40 foot swimming pool at his cottage on RD #3, Leechburg, Pa.

On 4/20/61 SA FORSYTH personally observed the Rossmont Plan of homes in New Kensington and noted that only eight homes are built and being lived in and one house is under construction. The latter is at the stage where it is under roof and is being insulated. Neighbors and workmen did not know for whom the house was being built.

Pittsburgh will attempt to learn exactly where MANGINI's house will be located in the Rossmont Plan.
