On 5/4/61, PG 615-C advised SA THOMAS G. FORSYTH, III, as follows:

Installation of the swimming pool at GABRIEL MANNARINO's cottage near Leechburg, Pa., will start any day. Although VICTOR STANZIANO, local swimming pool contractor, will do most of the work, GABRIEL MANNARINO will use equipment at his disposal to make the excavation. The pool will be a model, and STANZIANO will bring future pool prospective purchasers to see it. In exchange for allowing STANZIANO to do this, MANNARINO will pay only the cost price, estimated to be around \$2,500.

It is noted that the same VICTOR STANZIANO will do the home construction development on the MANNARINO-owned 400 acre tract of land in Allegheny Township, near Leechburg, Pa.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
