It is noted that PG 545-C advised that as of the early 1950's he knew PHILLIP BETTOR to be the bookkeeper of the MANNARINO organization as regards their income from illegal sources. This informant now is not certain as to whether or not BETTOR currently maintains books but has no reason to believe he does not.

On 5/10/61, informants and sources of the Pittsburgh Office, familiar with some phases of the MANNARINO activities, were alerted to develop as much information as possible regarding BETTOR's activities, associates, habits and travel. The above information, when received, will be reviewed with a view towards determining the possibility of contacting a highly confidential source who might reveal whether or not BETTOR is still the MANNARINO bookkeeper.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
