On 5/9/61, PG 612-C advised SA THOMAS G. FORSYTH, III as follows:

The men operating the Mannarino-controlled horse room at 1195 Fifth Ave., New Kensington, Pa., are being considerably more careful in recent days than they have been heretofore. Now they will not allow strangers in the horse room, and they will not take a telephone wager unless they know the caller by name or voice..

Gamblers in New Kensington predict a "lot of trouble" in the forthcoming primary elections. The Mannarino group favors re-nomination of incumbent Mayor RAYMOND GARDLOCK and if the oposition group appears to have too good a chance of defeating GARDLOCK they are expected to "pull off something big." Perhaps they will attempt to switch voting machines.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
