Since the article appeared in Pittsburgh newspapers concerning the Government's intention to have all investigative agencies cooperate in an attempt to combat organized crime, word has been passed around in New Kensington gambling circles each person so engaged should be particularly alert for the presence of strangers who could be Federal agents. Each numbers writer, horse bookie and sports bookie has been cautioned not to accept business from people with whom they are not already acquainted and they are not to accept any telephone wagers unless they are absolutely certain of the identity of the person calling.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
