With regard to PHILLIP BETTOR, who has been reported previously to have been bookkeeper for the MANNARINO organization, on 5/15/61, PG 545-C advised SA THOMAS G. FORSYTH III as follows:

PHIL BETTOR has an upstairs apartment, consisting of bedroom, bath, kitchen and living room, in a building he owns on Route 356 near the junction of Route 66, RD 2, Apollo, Pa. The lower floor of this building is "Dave's Market," a grocery store operated by DAVE NAMEY, who is BETTOR's brother-in-law. Since BETTOR is unmarried he lives alone but Mr. and Mrs. DAVE NAMEY live in an apartment next to his.

BETTOR works daily in his Army Surplus Store on Fifth Avenue, New Kensington, Pa. On Thursday and Saturday the store is open until 9PM and on other days, except Sunday, it closes at 6PM. Generally, BETTOR goes home to his apartment after his store closes although occasionally he has "dates" with Jewish friends. BETTOR no longer frequents the clubs in New Kensington but once in awhile he goes to the various supper clubs in Monroeville, Pa.

If BETTOR still keeps books for the MANNARINOS, it is unlikely that he does so at his apartment. It is more probable that he keeps them in his second floor office at the rear of his store, where there are necessary items like adding machines and file cabinets.

Informant, who can visit BETTOR either at his apartment or his store, will attempt to obtain more information to resolve the question concerning BETTOR and the MANNARINO books.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
