On 5/25/61, PG 615-C advised SA THOMAS G. FORSYTH III as follows:

There was very little activity in the MANNARINO controlled Bachelor's Club, New Kensington, Pa., "after hours" and gambling club, during the night of 5/24-25/61. Present was ABE SEID, aka AL ROSS, who is reputedly the MANNARINO "trigger man." SEID was released from the Federal Penitentiary, Lewisburg, Pa., on 5/22/61 and came directly to New Kensington. He is having a whole new wardrobe of lightweight suits made by a New Kensington tailor, which should be ready in a few days. SEID claims he has a job waiting for him in Florida, but he was not specific about it. He plans to join his wife somewhere in Florida as soon as he can leave New Kensington, and he will depart by personally owned automobile.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
