On 6/15/61 PG 612-C advised SA THOMAS G. FORSYTH, III:

The area of Monroeville, Pa., along U. S. Route 22, is now commonly referred to by gamblers from New Kensington, Pa., and from other sections of Western Pennsylvania as "The Strip." The reason for this is that much of the highway commerce is made up of nightclubs and cocktail lounges, usually operated in connection with a motel. These places have become hangouts and ostensibly casual meeting places for racket figures, large and small, and the MANNARINO underlings and associates are frequenting these establishments more and more. GABRIEL MANNARINO shows up once or twice a week, and SAM MANNARINO appears less frequently. Principal among the places visited are the Holiday House, the Town House and the Phoenix Motel.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
