Reairtel set out that the MANNARINOs and contractor VICTOR STANZIANO, all of New Kensington, Pa., plan to organize a new corporation for the development of 400 acres of land owned by the MANNARINOs near Leechburg, Pa.

On 6/22/61 PG 615-C advised SA THOMAS G. FORSYTH, III that VICTOR STANZIANO, who owes informant about \$25,000, has told informant that he will attempt to get him a "piece" of the new corporation. Informant believes, if such an arrangement can be made, that he will be in a position to get closer to the MANNARINOs, and he intends to bend every effort to bring it about.

BOTH SUBJECTS SHOULD BE CONSIDERED ARMED AND DANGEROUS.
