On 7/7/61, PG 615-C advised SA THOMAS G. FORSYTH, III as follows:

SAM MANNARINO has been out of town for three days and will return to New Kensington, Pa., either 7/8/61 or 7/9/61. All that is known is that he went "down South" someplace.

Currently, KELLY MANNARINO has two new, large rooms being added to his cottage. Over-all supervision of the job is being handled by VICTOR A. STANZIANO, but the carpentry work is being done by two men, allegedly from Canada.

In SAM MANNARINO's absence, STANZIANO is driving MANNARINO's car.

The public fishing lake on Route #56, near SAM MANNARINO's Bonfire Restaurant, is to be drained and filled. This land will be part of the site for the new road to be built which will give access to the new homes and shopping center STANZIANO will construct in concert with the MANNARINOS.
