Neighborhood sources and contacts advise ROSSELLI has been residing in Los Angeles during the past two weeks. Las Vegas Office advised ROSSELLI checked into Desert Inn Hotel about noon on 4/10/64.

WILLIAM WEISS, contact of ROSSELLI, advised that in latter part of March, 1964, ROSSELLI requested WEISS to permit Selena Enterprises, Inc. to occupy office space at 8490 Sunset Boulevard, Los Angeles, without paying rent, for two or three weeks. WEISS agreed to do so.

Selena Enterprises, Inc. is California Corporation engaged in representing entertainment personalities. Incorporators are ROBERT ABRAMS, BERNARD RICH and ALVIN FISHER. Records, State of California, Corporations Division, failed to reflect ROSSELLI has any interest in this corporation. ABRAMS formerly associated with ROSSELLI in 1958 in Nevada Concessions, Inc. which corporation had concessions at the Tropicana Hotel in Las Vegas.

LA 4145-C advised ROSSELLI has ordered 24 ice machines from Ajax West Coast Corporation, Santa Barbara, California, for installation at the Desert Inn Hotel, Las Vegas, Nevada. This represents approximate profit of from \$15,000 to \$18,000 to ROSSELLI.
