West Coast Corporation. On 4/7/64 he deposited a check for \$13,945.50 which was drawn on the Bank of Las Vegas. These checks probably represent the purchase and sale of ice machines. It is recalled that recently LA 4145-C furnished information that ROSSELLI had recently purchased 24 ice cubemaking machines from Ajax West Coast Corporation, Santa Barbara, for resale to the Desert Inn Hotel, Las Vegas, Nevada.

On 4/7/64 ROSSELLI also deposited fifteen checks in small amounts totaling \$41.74 which probably represent dividends from investments in oil leases as some of the checks are drawn on Texas banks from which banks ROSSELLI has in the past received checks for oil lease dividends.
