LV 10-C advised that on 4/27/64, ROSSELLI, through MIKE RICH, Manager, Desert Inn Hotel, made reservation at this hotel for 4/28/64 and indicated he would be there for six days. He was assigned room number 2801.

The records of the Union Bank, 8th and Hill, Los Angeles, California, reflect that EMANUEL ROTHMAN, ROSSELLI's Accountant, maintains an account, number 10079-3592 at this bank. On March 11, 1964, a \$5,000.00 check payable to JOHN ROSSELLI and drawn on the account of INES CHAPMAN, Beverly Hills, California, was deposited to this account. The check bore a notation "for 2000 Pacific Vitamin" which probably indicates the sale of stock of Pacific Vitamin Corporation. Identity of CHAPMAN not currently known.

Union Bank records also reflect that on 3/10/64 a check for \$1250 was drawn on this account payable to Glen Towers Apartments, and a notation on this check indicated it was for "February and March, 1964, rental for apartment number 803 and extra parking space." On 4/1/64, a check for \$550 was also drawn payable to Glen Towers Apartments for April rent.

On 4/10/64 a check was drawn on the account for \$1500 payable to Selena Enterprises, Inc. A notation on the face of the check indicated the money was for a "Loan." The check was endorsed by ROBERT ABRAMS and BERNARD RICH, and deposited at the Bank of America, Sunset - La Cienega Branch, Los Angeles.

Information concerning Selena Enterprises, Inc., a firm representing entertainment personalities, has been previously furnished to the Bureau. It is recalled that ABRAMS and RICH are officers of the company and ABRAMS is a friend and associate of ROSSELLI.
