


The Bureau has been advised that ROSSELLI and a red-haired girl named KATHY HORDEN, aka, were observed arriving in Las Vegas together on 4/28/64 and that shortly after their arrival HORDEN was interviewed and denied that she and ROSSELLI were traveling together and said that she had not been with ROSSELLI, although they were on the same plane. In this regard, information was also furnished the Bureau that on 4/28/64 ROSSELLI was in Santa Barbara with a woman. Photograph of KATHY HORDEN will be shown to the source in Santa Barbara to determine if she is the girl who was with ROSSELLI.

On 5/4/64 it was learned from examination of records of TWA that "RUSSELLI" and HORDEN were passengers on TWA Flight 196 from Los Angeles to Las Vegas on 4/28/64 and they occupied adjacent seats. The records of the airline showing where the reservations were made and by whom have been forwarded to NYC and will not be returned to Los Angeles for about three weeks.

On 5/4/64 the Las Vegas Office advised that LV 10-C furnished information that on 2/28/64 ROSSELLI called ROBERT MAHEW (phonetic), telephone number 454-6535, Santa Monica, California, (from the Desert Inn Hotel, Las Vegas). (This is the telephone number of ROBERT MAHEW, 642 Toyopa Drive, Pacific Palisades, California, and the Bureau is aware of MAHEW's identity and association with ROSSELLI.) LV 10-C further advised that the arrival sheets reflecting guests checking into the Desert Inn Hotel reflects that a Mr. and Mrs. R. MAYHEW (phonetic) checked into this hotel on 4/28/64.

LV 10-C also stated that on 4/29/64 ROSSELLI received a call from a Mr. BUNNY FISHER, telephone number 276-9046₃ and on 4/29/64 a call from the same individual at Los Angeles telephone number 656-8774 and that ROSSELLI did not talk on either call.

On the evening of 5/6/64 at approximately 7:20 p.m. SAs of the Los Angeles Office observed ROSSELLI riding as a passenger in a white 1964 Pontiac "Grand Prix" bearing Nevada license CF 9679. The only other passenger was a woman who was driving. They were first observed in Westwood Village and they then proceeded to Kirkeby Center in Westwood Village where they parked the car. They no doubt proceeded to the roof of Kirkeby Center where there is a fine restaurant where ROSSELLI has been known to have dinner in the past. At approximately 1:30 a.m., 4/7/64, ROSSELLI's Thunderbird and the above-mentioned Pontiac with Nevada plates were observed parked in the two stalls assigned to ROSSELLI in the garage at his new residence at 1333 South Beverly Glen Boulevard, Los Angeles.

On 4/8/64 at approximately 2:00 p.m., SAs of the FBI observed ROSSELLI's car parked at Perino's Restaurant on Wilshire Boulevard in Los Angeles. On the same date LA 4129-C furnished information that ROSSELLI was having lunch at Perino's with JULES ROTH, who is the head of the Hollywood Cemetery Association, Los Angeles. Informant stated that ROTH is a good client of the restaurant. The Los Angeles Telephone Directory reflects this cemetery is located at 6000 Santa Monica Boulevard, Los Angeles.

The Las Vegas Office is requested to advise Los Angeles the owner of Nevada automobile license CF 9679.
