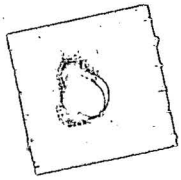

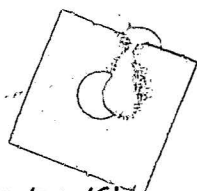

LA 4268-C advised that ROSSELLI was at the Friars Club, Beverly Hills, California, on the afternoon of May 25, 1964, when informant arrived there at about 4:30 P.M. At that time ROSSELLI was playing "Gin" with BUDDY JACKLER. The game was discontinued at about 5:45 P.M. at which time ROSSELLI was observed paying JACKLER \$100 for his losses during the game. Thereafter, ROSSELLI was observed in conversation with HERMAN SPITZEL, a former insurance broker and friend of ROSSELLI and an associate in the past with numerous persons in the criminal field. ROSSELLI was also observed in conversation at the club with MORRIS "MOE" GENSER, former official of the Enforcement Division of the California Department of Motor Vehicles who was discharged from his position and against whom the State of California has filed criminal charges.

BUDDY JACKLER, according to LA 4268-C, is owner aware of Cardinal Sales, a vending machine company handling only cigarettes.

The same informant again observed ROSSELLI at the Friars Club on the afternoon of May 26, 1964, and ROSSELLI was again playing "Gin" with BUDDY JACKLER. At the conclusion of the game, informant observed ROSSELLI hand JACKLER two "bills" for his losses but informant did not see the denominations of the bills. After concluding the card game, ROSSELLI talked with MAURICE H. FRIEDMAN (who is a part owner of the hotel Last Frontier Corp. and a close associate of ROSSELLI's). ROSSELLI left the card room at
