We received a copy of a State Department Airgram to the effect that subjects would be departing from San Francisco about 1-1-66, for a six-month to one-year trip abroad, to include Ghana and "Germany." (u)

Based on prior information furnished by the Bureau we alerted the Consular Affairs Section, U. S. Mission Berlin; the 513th Intelligence Corps Group, U. S. Army Europe; and [S] the Bundesamt fuer Verfassungsschutz (BfV - West German Federal Agency for the Protection of the Constitution) by letters dated 1-6-66. Information furnished these agencies was that contained in the Department of State Airgram dated 12-20-65, designated CA-6446. (u)

If any information is received from our sources concerning subjects, it will be promptly reported.
