On 5/1/63 Las Vegas Office advised ROSSELLI residing Room 25, Desert Inn Hotel, Las Vegas. U

LV 10-C advised that on 4/30/63 ROSSELLI received telephone call from a Mr. MAHEU. ROSSELLI was not in and a message was left for him to call MAHEU, city not stated but probably in Los Angeles. MAHEU is probably ROBERT MAHEU, Private Investigator and former Bureau Agent with whom ROSSELLI has been in contact on numerous occasions in the past. U

ROSSELLI probably returned to Los Angeles, evening of 5/1/63, as Los Angeles Police Department (LAPD), Intelligence Division, Airport Detail, advised that he was a passenger on Western Airlines Flight #24 for Las Vegas, which left Los Angeles at 10:30 AM on 5/2/63. U

Las Vegas Office advised on 5/7/63 that ROSSELLI still in Las Vegas. U

LAPD, Intelligence Division, advised that on 5/2/63 MAURICE H. FRIEDMAN and JACK BARENFELD, both friends of ROSSELLI, left Los Angeles on that date on Western Airlines Flight 601, enroute to Mexico City, and Acapulco, Mexico. LAPD advised that a Mrs. MARLENE SLATER and a MARY ANN SHIELDS accompanied FRIEDMAN and BARENFELD. U
