RICHARD CYRIL FRANK, born at Rochester, New
York, on August 23, 1922, arrived from New York on
May 5, 1964, at the Malpensa Airport in Milan,
Italy, on Alitalia flight number 603. (S)

RICHARD CYRIL FRANK, of whom there is no
record of residence in Italy, presumably left
shortly thereafter for an unknown destination. (S)
