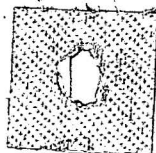

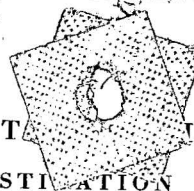

Re New York letter to the Bureau 3-1-65.

The question raised in re New York letter relative to funds from China being used to finance publications of the Progressive Labor Movement (PLM) has been discussed by the writer with Superintendent Higgitt and Sergeant Stewart, Directorate of Security and Intelligence, RCMP Headquarters, and it is understood from such contact that no information which would confirm such use of Chinese funds has to date come to the attention of the RCMP. The RCMP, however, have been asked to promptly make available to this office any information along the above lines and the Bureau will be advised accordingly, should such data be forthcoming. (S)
