F-1 Lookout Notice re subject placed with INS 9/9/70;  
however, no information has been received from INS indicating he  
returned to the US.

Review of the paid checks pertaining to the account of  
subject and his wife, SUSAN H. FRANK, at the Chemical Bank, NY,  
NY, indicates subject possibly returned to the US some time  
during the first part of November, 1971. The earliest check  
negotiated by subject was dated 11/9/71 at NY and also cleared  
through a local bank on the same date.

\*NY [5181]-S advised subject's wife was among those at  
JFK International Airport, NY, 11/11/71 to welcome the arrival  
of the People's Republic of China (PRC) Mission to the UN  
delegation, and she had advised source she returned to the US  
on 11/9/71. It is noted subject's wife reportedly entered  
Mainland China on 8/18/71. (S)
