Please refer to your W.2269 dated 1st November, 1971.

2. FRANK arrived in Hong Kong from Los Angeles on 24th September, 1971. He was travelling on U.S. Passport No. B1942048 issued in New York City on 9th August, 1971. He left Hong Kong by rail for Canton, China on 28th September, 1971, and returned to Hong Kong on 22nd October, 1971. He left Hong Kong by air on 23rd October, 1971, for Tokyo.

3. On his first visit to Hong Kong, FRANK stayed at the Mandarin Hotel. After his visit to China, he stayed at the Golden Gate Hotel. It is believed that he travelled without his wife.
