ON MAY 23, 1974, NY 14323-PC CONTACTED SA RICHARD A. GENOVA OF THE NEW YORK OFFICE AND ADVISED THAT DALTON SMITH HAD ADVISED HIM THAT BECAUSE OF HIS PENDING INDICTMENTS AND PREVIOUS SENTENCING HE WAS ABOUT TO LEAVE THE COUNTRY. SMITH FURTHER ADVISED PC THAT HE DID NOT WANT TO SPEND ANY TIME IN JAIL AND, THEREFORE, GETTING READY TO LEAVE THE COUNTRY THUS AVOIDING BEING ARRESTED.

ON MAY 31, 1974, THE ABOVE INFORMATION WAS FURNISHED TO LOS ANGELES STRIKE FORCE ATTORNEY ROBERT S. THALLER AND WAS SUBMITTED IN AFFIDAVIT FORM BY HIM TO THE TENTH CIRCUIT COURT.
