

added that approximately three months ago while in Washington, D. C., to visit a friend in the Greek Diplomatic Service at the Greek Embassy, he stopped at the Department of Justice to say hello to MR. ANDERSON, but he was not in Washington at the time said that upon his return to Pittsburgh, Pa., he received a personal note from MR.
