GABRIEL MANNARINO SAMUEL MANNARINO ANTI-RACKETEERING

For your information the following data appeared in a communication of July 6, 1959, from the RCMP to the Legat at Ottawa:

"In addition, we are advised that a Sam Mannarino, brother of Apalachin delegate Gabriel Mannarino, is active in criminal activities in the Pittsburgh area. This undoubtedly is the Sam Manmarino of New Kensington, Pa., who was arrested recently by your Force and charged with aiding and abetting William Rabin in disposing of stolen Canadian bonds. Sam Mannarino is believed to have a criminal record. A Sam Mannarino of 33 N. La Salle Street, Chicago, is believed to have visited Montreal on several occasions this year, and has been under suspicion in regard to narcotic and other illicit activities. It would be appreciated if you could supply a photograph and record of the Sam Mannarino who operates in the Pittsburgh area, for identification purposes at Montreal."

Copies of the current identification record of Samuel Mannarino, FBI number 114 840, together with copies of his most recent photograph have been forwarded for transmittal to the RCMP.
