FG FIVE SEVEN THREE DASH C ADVISED THAT ABOUT FIVE MONTHS  
AGO, ALL OF THE EMPLOYEES OF THE JOCKEY CLUB, A PLUSH GAMBLING  
ESTABLISHMENT IN CHESTER, W. V., OPERATED BY CHARLES  
FREDERICK TEEMER, ATTENDED A MEETING AT THE RED EAGLE LOUNGE,  
PITTSBURGH, PA., PRIOR TO THEIR DEPARTURE FOR THEIR EVENING-S  
WORK AT THE JOCKEY CLUB. GABRIEL MANNARINO CALLED THE
