DEPT. ATTORNEYS IN PGH HAVE ADVISED THAT DURING IRS RAID ON AUGUST TWENTY FOUR LAST AT MANNARINO HORSEROOM IN NEW KENSINGTON, PA., TWO TELEPHONE LINES AND A TICKER TAPE WERE LOCATED BUT THAT INVESTIGATION FAILED TO DETERMINE BY WHAT MEANS INSTANTANEOUS ANNOUNCEMENTS CONCERNING PROGRESS OF RACES WERE RECEIVED. ON DECEMBER ELEVEN, LAST, PG SIX TWO ONE DASH C MADE AVAILABLE FOR INTERVIEW HIS BROTHER WHO HAS IN PAST WORKED TICKER TAPE AT MANNARINO HORSE ROOM. HE ADVISED PROGRESS OF RACES WAS ANNOUNCED AS RECEIVED ON TELEPHONE LINE EDISON NINE DASH NINE FOUR FIVE FOUR, SOURCE NOT KNOWN. HE ALSO ADVISED TICKER TAPE WAS FROM CHICAGO, ILLINOIS, AND RELAYED RESULTS OF RACES RUN AT TRACKS IN THAT AREA. INFORMATION WAS DISSEMINATED LOCALLY TO DEPT. ATTORNEYS AND IRS MORNING OF DECEMBER TWELVE, INSTANT. BUREAU WAS ADVISED DECEMBER TWELVE, INSTANT, BY
