On October 14, 1969, NO 1677-C-TE advised SA THOMAS E. DUHADWAY that FRANK CARACCI continues to frequent the New Orleans Athletic Club on a daily basis to play cards. Source advised that CARACCI informed him that he was not worried about his recent arrest in Houston, Texas, for possession of bookmaking materials and said "We have the fix in."

Source advised that he has never known CARACCI to be a bookmaker, but added that he is a big bettor and that in the past when he handled CARACCI's account he often became involved in three-way conversations between CARACCI, TICKIE SAIA, and himself.

Source advised that he never dealt personally with TICKIE SAIA, but it was apparent from his dealings with CARACCI that SAIA and CARACCI pool bets together.
