On 9/15/71 NO 1899-C-TE advised that an individual by the name of STEVE PERKINS, who drives a vehicle bearing current Louisiana license 48B878, is a big bettor with CURLEY at 500 Carondelet. Source advised that PERKINS often drives CURLEY to the bank for deposits. Source further advised that an individual who goes by the nickname of "BROTHER" (LNU) had just started booking in Exchange Alley, and advised source that he was booking for CURLEY GAGLIANO. Source advised that "BROTHER" used to book for SAM SATA and further Advised that "BROTHER's" line is different from that of other walking bookmakers in Exchange Alley.

On 9/19/71 NO 1960-PC advised that he made a bet with "CURLEY" at Curley's Corner on St. Charles Avenue.

On 9/23/71 NO 1899-C-TE advised that he had placed a bet with "BROTHER" in Exchange Alley. Source described "BROTHER" as a white male, Spanish appearing, wearing cast on the neck.

On 9/27/71 NO 1960-PC advised that he placed a bet with CURLEY GAGLIANO on 9/26/71.

On 9/30/71, NO 1899-C-TE advised that he called a pay phone in Exchange Alley which has number 523-8409 and placed a bet with "BROTHER" who is working in the Alley.

On 10/7/71, NO 1899-C-TE advised that "BROTHER" had gone bankrupt and had stopped booking in Exchange Alley. Source advised that he learned that "BROTHER's" first name was JOHNNY.
