ANGELO BRUNO's prolonged absence from Philadelphia, presently visiting Palermo, Italy, confirms for sources PH 591-C* and PH 614-C-TE that PETER MAGGIO handling BRUNO's legal business interests while PHILIP TESTA is handling BRUNO's illegal interests. MAGGIO, during the current week at BRUNO's request pressured RAYMOND MARTORANO and today collected \$8,000 from MARTORANO for payment due BRUNO from sale Penn Jersey Vending, Inc., service contract. TESTA apparently acting as number two man in Philadelphia settling "Family" disputes in behalf of BRUNO. However, interest to note that ANTONIO POLLINA, BRUNO's predecessor, "Representando Officiale", Philadelphia Family "La Causa Nostra," has conferred during past week and did confer 4/15/63 with MARIO MAGGIO and PETER MAGGIO first in effort to raise funds to buy out a partner in Medallion Provisions Company; failing to do so, obtained their counsel for POLLINA to sell his interests. POLLINA is the only person known to sources who seeks assistance outside of BRUNO's or TESTA's sphere of influence.
