The title is marked changed to record subject's true name as ANTONINO ANGELO ANNALORO as furnished by the Italian National Police on 4/17/63. (S-1)(u)

OTHER 4

ReBucab 4/11/63 which advised that a source had said ANGELO BRUNO called his associate, PETER MAGGIO, in Philadelphia from Italy on the evening of 4/8/63 and indicated he had seen his cousin, CALOGERO SINATRA. BRUNO was also to have called MAGGIO'S home again on Easter Sunday at 11:00 p.m. from Italy.

On 4/12/63 this matter was personally discussed with [redacted] Central Bureau, Criminal Division, Italian National Police, Rome, Italy, who immediately dispatched a telegram to appropriate police districts in Italy to verify the presence in Italy of subject and his wife and determine details of their travel and activities while in Italy. (S-1)(u)

On the evening of 4/17/63 Doctor BALDESAR, Central Bureau, Criminal Division, Italian National Police, Rome, advised that he had received information from Italian police in Caltanissetta, Sicily, that ANGELO BRUNO is identical with ANTONINO ANGELO ANNALORO, born 5/21/10 in Villalba, Caltanissetta, Sicily, the son of MICHELE and VINCENZA CUMELLA. (S-1)(u)

According to BALDESAR, subject lodged at the Hotel di Prima in Caltanissetta from 3/27/63 to 3/31/63. He was accompanied by his wife, ASSUNTA, and had in his possession U. S. passport number C-707705. BALDESAR stated that Italian police in Caltanissetta were able to determine that on 3/30/63 subject called a cousin (possibly CALOGERO SINATRA) in Vallelunga, Caltanissetta, and later with his wife visited a cousin, ANGELO ANNALORO, and an uncle, DAMIANO CUMELLA, in Villalba. (G-1)(u)

BALDESAR advised that subject left Italy on or about 4/10/63 for Germany and from Germany was to travel to Florida. The method of travel for subject is unknown. BALDESAR further advised that according to police investigation in Caltanissetta, subject was not in Italy during Easter, made no other telephone calls, nor did he make any other known stops while in Italy. (G-1)(u)

For the further information of the Bonn Office, referenced Bureau cable advised that subject's last definitely known whereabouts was Miami, Florida, 3/31/63. [In view of this information, the Rome Office recontacted BALDESAR on 4/18/63 who is rechecking with Italian police to make certain the dates subject lodged at the Hotel di Prima are correct.] (G-1)(u) Subject is an extremely important top hoodlum and is believed to be a member of the "Commission," ruling group of "LaCausa Nostra" and head of the Philadelphia area "Family."

This information was telephonically furnished to the Bonn Office on 4/18/63.

Bonn is requested to verify subject's presence in Germany and to determine details of his travel and activities while in Germany. (X)(u)

Rome Office is following this matter with Italian police and will advise Bureau and interested offices promptly upon receipt of any information. (S)(u)
