PH 623-C* ON MAY 4 LAST, INFORMED BRUNO AND FRANK NICOLETTI ACCOMPANIED BY UNKNOWN MALE WHO CLAIMED TO BE TELEPHONE COMPANY EMPLOYEE, EXAMINED PREMISES. UNKNOWN MAN APPARENTLY [REMOVED FROM WALL BUT DID NOT DISCONNECT A 42 A BLOCK WHICH PARTIALLY SERVICED] PH 623-C*. SAME PERSONS DISCUSSED SIMILAR ACTION RE [42 A BLOCK SERVICING] PH 647-C*. UNKNOWN MAN STATED REAR OFFICE "CONNECTING BLOCK DIFFERENT", THEN TOLD BRUNO "YOU GOT TO CHANGE THAT, BOY". UNKNOWN MAN SPECIFICALLY EXPRESSED OPINION THAT FRONT OFFICE "NOT BUGGED". [TO PROVIDE SECURITY AND ELIMINATE POSSIBILITY BRUNO GETTING POSSESSION ALTERED 42 A SERVICING REAR OFFICE AND 42 A SERVICING] PH 647-C*, BOTH REMOVED MAY 5 IN EMERGENCY OPERATION. COMPLETE SECURITY MAINTAINED. [DUE TO INADEQUATE TIME ALTERED 44 A BLOCKS IN FRONT OFFICE NOT REMOVED.] [ALTERED 44 A BLOCKS IN FRONT OFFICE NOT REMOVED] AS NOT FELT NECESSARY

PRIOR BUREAU PERMISSION NOT REQUESTED FOR REMOVAL, DUE TO EMERGENCY SITUATION AND BECAUSE IMMEDIATE OPPORTUNITY FOR SECURE ENTRANCE EXISTED.

SUGGEST OTHER OFFICES USING [ALTERED 42 A BLOCKS] IN CI PROGRAM BE ADVISED OF ABOVE SITUATION.

PH 623-C* BEING AFFORDED 24 HOUR COVERAGE TO DETECT FURTHER SIMILAR ACTIVITY BY BRUNO. VIGOROUS ACTION BEING TAKEN TO IDENTIFY ALLEGED TELEPHONE COMPANY EMPLOYEE.

RECOMMENDATIONS FOR COMMENDATIONS FOR PERSONNEL INVOLVED WILL BE SUBMITTED. BUREAU WILL BE KEPT ADVISED.
