On 6/13/63, BRUNO observed meeting AUGIE AMATO at 1:00 P.M., Hialeah, Fla. BRUNO and AMATO spent considerable time together and later both went to Pumpernik's Restaurant, North Miami, Fla., where they were observed at table with JOE MANGONE, GUY GULLY, PCI [redacted] and 2 unknown males. One of two unknown males departed restaurant with JOE MANGONE, and is believed to be possibly identical with CARL IPPOLITO. Other unknown male departed restaurant and drove away in tan Cadillac bearing Va. license No. 572-658.

Surveillance maintained on BRUNO until 5:44 P.M., 6/13/63.

On 6/17/63, VARIG Airlines confirmed BRUNO (as ANGELO B. ANNALORO), and SUE BRUNO (as ASSUNTO BRUNO) departed Miami 7:00 P.M. 6/13/63, via Varig Flight No. 801, for Santo Domingo, D.R. BRUNO left with round trip open return tickets but no evidence has been developed to date indicating he has returned.
