Information has been developed indicating that the subject is not in the New York area. NY 4047-S* has revealed that the subject has not been at home for about five days. The Subject's wife has indicated that he is "away". DAVID REID, superintendent, 39 Cortlandt St., NYC, stated that he has not seen the subject in about a week. Subject withdrew \$700 from the bank on 5/1/64.

A stop has been placed locally with INS so as the NYO will be alerted if the subject returns from some place outside the U.S. Other sources have been alerted to inform the NYO if he is seen at 39 Cortlandt St. or 110 Christopher St., NYC.

It is recommended that the Bureau alert the Legat, London in the event MI-5 becomes aware of the subject's presence in England in the course of their coverage of JACK PERRY. (S)
