It is to be noted that to date, the subject's checking account at the Chemical Bank New York Trust Company, Grove and West Fourth Streets, NY, NY, does not show that the subject wrote a check for his ticket to Milan. This, coupled with the fact that he refused to give Alitalia an address or telephone number where he could be reached, seems to indicate that he did not want his trip to Europe to become known.

The Bureau is requested, through Legat, Rome, to determine, if possible, the subject's activities in Milan, Italy. It is also requested that it be determined if TANG Ming-chou, also known as CHU TONG, an official of the People's Republic of China, was in Milan at the same time as the subject. (S)

It is also requested that the Bureau point out to the Legat, Rome, that it was reliably reported that in September, 1963, the subject contacted TANG Ming-chou in London, and that it has also been reported that TANG is in charge of Political Intelligence for the People's Republic of China as it pertains to English-speaking countries.

When the records become available at INS, NY pertaining to arrivals about 5/19 or 20/64, these records will be reviewed to determine subject's method of return to the United States.
