It was learned that MANNARINO is under doctor's care and has a personal physician travelling with him, who has now been identified as Dr. Donald SHOEMAKER of RR #1, Leechburg, Pa., U.S.A. (Note correction in the spelling and address of Dr. SHOEMAKER, who was previously mentioned in our correspondence of November 23rd, in paras. 3 and 8.)

Address is now given as 1060 - 3rd Avenue, New Kensington, Pa., U.S.A.
