Washington County, Pa. Numerous sources had previously referred to ZEID as a "trigger man" for the MANNARINOs of New Kensington, Pa., and other "syndicate groups" for many years.

On January 11, 1966, PG T-5 advised:

If the Federal Bureau of Investigation were to check and find out the identities of two young men whom SAM MANNARINO was instrumental in getting out of United States Penitentiary, Lewisburg, Pa., approximately one month before MANNARINO himself got out, two of the murderers of AL ROSS would be known.

On February 18, 1966, PG T-3 advised:

Recently, it was suggested to MANNARINO that he may have had some part in the shooting murder of AL ROSS in 1965. MANNARINO laughed and stated that this would have been impossible since he was not released from the penitentiary until June 1, 1965. MANNARINO treated with disgust the rumor that he had managed to secure the release of two young inmates from the penitentiary and had hired them to do the shooting. MANNARINO said he had not grown so old as to be stupid enough to send a couple of "young punks" to do his killings for him and possibly put him in the electric chair. He stated that he had done his share of killings in the past, and if he were going to do one today, he would do it himself, possibly accompanied by someone with whom he has done business for a great many years.

La Cosa Nostra

On February 18, 1966, PG T-3 advised:

Recently, during a conversation with MANNARINO, MANNARINO stated "we" don't get involved in murders anymore, the way "we" used to do in the 1930's. MANNARINO said there had not been a racket killing in the Pittsburgh, Pa., area, up until the shooting of AL ROSS, for 30 years. MANNARINO was asked how he could makey that statement with the frequent murders in the Chicago, Ill., area, and in the recent past, in Youngstown, Ohio. MANNARINO replied that

ILLEGAL ACTIVITY

On 2/4/66, PG 775-C advised SA THOMAS G. FORSYTH, III:

Since at least 1958, SAM MANNARINO has not been known to be active in, or a beneficiary of, illegal activities in his home territory of New Kensington, Pa., or anywhere else. Prior to that time, he was the "Boss" of all gambling and related activities in the northern part of Westmoreland County, Pa., and he actively took part in their management. However, a schism occurred between SAM MANNARINO and his younger brother, GABRIEL MANNARINO, reason not known, and since then, for all practical purposes, SAM MANNARINO has been retired and control of rackets has passed on to GABRIEL MANNARINO. SAM MANNARINO keeps busy in the management and promotion of legitimate business interests.
