In our correspondence dated November 23, 1965 on the CAPOLINOs et al, it was mentioned that the CAPOLINOs were very provocative to their guide during their recent hunting trip in the interior of British Columbia. The guide in question was one Franz PRUCKL, who enjoys a good reputation with the Provincial Game Department and operates the Beaver Ranch Outfitters, P.O. Box 88, Cheywynd, B.C.

B. APPROX. 1931

2. Recently, PRUCKL complained to our Detachment at Prince George, B.C. that he is being subjected to a malicious campaign by the CAPOLINOs to discredit his reputation as a big game guide and outfitter. According to Mr. PRUCKL, one Robert AGNELLO, approximately 35 years of age, who operates a Plumbing and Heating firm at 182 - 28 80th Drive, Jamaica, New York 11432, is writing letters to various persons in the United States trying to bring discredit to PRUCKL's reputation. PRUCKL advised our members that, in the Fall of 1964, he was a guide for Robert AGNELLO and that AGNELLO had left B.C. after his hunting expedition very satisfied with the treatment given to him by Mr. PRUCKL. However, since the CAPOLINOs returned to New York from their hunting expedition with PRUCKL in September 1965, apparently, there is some indication that the CAPOLINOs have now asked Robert AGNELLO to support their disapproval of PRUCKL. According to PRUCKL, there is some suggestion that the CAPOLINOs, by some unknown means, are pressuring AGNELLO into supporting their attack against PRUCKL.

3. From investigation and information received to date, it appears that PRUCKL's accusations are factual and


