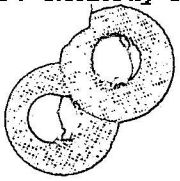

Re Philadelphia airtel to the Bureau dated 5/7/64, advising HAROLD KONIGSBERG's attorney, RAYMOND A. BROWN, officially withdrew as KONIGSBERG's attorney. BROWN stated KONIGSBERG is "indigent" and desired a court-appointed attorney.

NK 2381-C-TE advised on 5/9/64, that KONIGSBERG is not indigent, but, on the contrary, maintains a large sum of cash in his "cell" in the Hudson County Jail in Jersey City, N. J. Another reliable informant has confirmed this information.

NK 2381-C-TE stated that the largest volume of money comes in to KONIGSBERG on Mondays and Tuesdays, and goes out beginning on Wednesdays. This money is utilized in connection with KONIGSBERG's continued shylock operation. The informant has observed that this money is maintained by KONIGSBERG in a cabinet, and also under his pillow and mattress.

NK 2381-C-TE stated KONIGSBERG occupies a room, not a cell, on the third floor of the jail, occupied by a bed, table, cabinet, and other miscellaneous furniture, including a television set. KONIGSBERG alone occupies this room, and it is the only room on the third floor with a wooden door.
