On October 31, 1968, a source, who has furnished reliable information in the past, advised as follows: (S)(U)

On October 18, 1968, [EUGENIO MAXIMILIAN, Haitian Consul General] in Miami, Florida, stated that his government had recently instructed him to negotiate with the Cuban exile, MANUEL ARTIME, for the purchase of arms located in Nicaragua. These arms were originally stored in Nicaragua for use during the Bay of Pigs invasion of Cuba.

[MAXIMILIAN] stated that apparently [Haitian President FRANCOIS DUVALIER] had changed his mind about contacting ARTIME, because he, [MAXIMILIAN] had learned that day that the [Haitian Ambassador to Mexico, RUDOLPHE EDOUARD BABOUN] had been designated by [President DUVALIER] also to serve as [Ambassador to Nicaragua]. According to [MAXIMILIAN], BABOUN reportedly was supposed to present his credentials to the President of Nicaragua that day, October 18, 1968.
